## SUNWORLD TOUR TERMS AND CONDITIONS

---

### **DEPOSIT:**

Guaranteed \$300 per person deposit at time of booking. This deposit is NON-REFUNDABLE. Insurance, which is strongly recommended, must be purchased at time of deposit. The exact amount will be advised at the time of booking.

### **BALANCE OF PAYMENT:**

Guaranteed balance of payment required 90 days prior to departure. If the balance is not paid by the stipulated date, the right is reserved to cancel the booking(s) without further notice and without refund of deposit.

### **CANCELLATIONS:**

Cancellations received more than 90 days prior to departure will incur loss of the non-refundable deposit as specified above.

Cancellation penalties applicable thereafter:

25 % of total tour cost 45-89 Days prior to tour date

50 % of total tour cost 31 - 44 Days prior to tour date

100% of total tour cost less than 30 days prior to tour date

Changes for a confirmed reservation are subject to a \$100 admin fee per person/service

Other specific supplier and airline cancellation penalties may apply in addition to cancellation and amendment fees charged by Sunworld Tours. There will be no refund for unused land arrangements after departure. All cancellations are required in writing, and must be acknowledged by Sunworld Tours.

### **INSURANCE:**

If you are not a Canadian or USA passport holder, please check the Israeli consulate in your country for visa requirements. Also, check what visa requirements are necessary to enter back into Canada. If you hold a permanent resident card, bring it with you.
